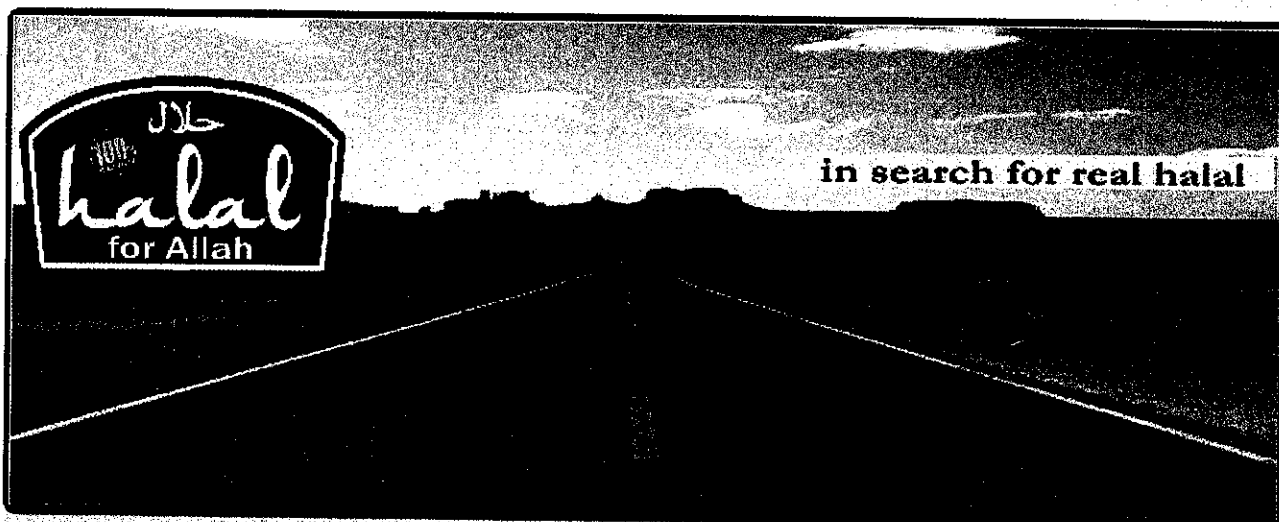

Collections were made in excess of a million dollars to construct Samabula Masjid where a bill of quantity totaled \$600,000.00 to complete, constituting a net loss of \$400,000.00, you can see yourself that the account balance is hardly \$2,000.00 and the masjid has been only three quarters finished with hardly any of the finishing's promised.

Dawah Account

You can see there is a balance of \$124,000.00 and they are utilizing this money to pay other unrelated issues and not a single penny is spent on Dawah. Again this is reflected by the financial records that they do not have a plan or method to spend on dawah work.

FML Apeal Fund

There is a balance of over \$200,000.00 in the account; this money has been sent by members all over the world for hurricane and flood relief appeal. The last flood and hurricane was about two years ago and our Muslim brothers and sisters have struggled to resume normal life and this money was never distributed to them. If you see the cash flow there are only 12 accounts represented and Samabula shopping complex account cannot be seen and there may be many more of which we may never know. Also if you go into the last 10 years financial account FML appeal fund has not been included at all. Respected brother Abdul Hakim is one of the members of FML management and he is also associated with the firm who audits FML accounts so one can evaluate the credibility of the audited accounts.

Samabula Shopping Complex

Bill of quantity was of 1.4 million dollars, but Hafiz Khan awarded the tender to working committee member of the time and his close relative for **\$2.4 million dollars**. FML paid almost 1 million dollars more than the cost, we took this matter to court and with the help of some munafiq members of FML and the false declaration of brother Subhan of Nasinu Muslim League we could not obtain a court order to stop construction and on the following

This institute project was totally funded by a foreign Islamic Institute and funds for running it were also provided. Scholarship funds were also funded so basically this whole initiate was not from the Muslim League's member's funds. Prior to the current corrupt President Hafiz Khan this institute was functioning well financially but as you know Allah SWT gives no success to people who sell Pork and Alcohol for a living. Same happened here Hafiz Khan steered the institute to a total bankruptcy. When the university was closed then Hafiz Khan went ahead and made deal with a non-Muslim group in Fiji to lease the property but after it came on the newspaper Nasinu Branch immediately acted on Hafiz Khan making him reverse the deal. Today the University is closed and officially bankrupt by its members and Hafiz Khan again falsified and moved a motion at a Council meeting that a Madrasa would be established and financially needy boys would be assisted. But the fact remains that it is a total wastage of Zakaat funds.

Duty free vehicle imported by Nasinu Branch.

Going back to the vehicle issue, the vehicle belongs to Nasinu Branch and its members but unfortunately it is being misused by Hafiz Khan to date and the purpose of tableegh and dawah was defeated again.

See yourself that FML head office account runs on overdraft and interest which is Haraam in spite collecting \$300,000.00 + in rental revenues and they spend the entire collection plus borrowing from bank on Overdraft on wages, telephone, overseas and local traveling. Current Financial's will be available shortly.

We wrote to our auditors and attached are the reply where one of the main concern is student levy account, Samabula mosque account and Zakaat account. All our concern is attached


We are writing to you brother since Dispute Resolution seems not to be functioning and if some how we could get some written reply from the auditors

Nasinu Branch League

Removal of the elected officials of Nasinu Branch League

Nasinu Branch officials resigned from their posts in a Council Meeting which was held at Magania Nadi reason being; allegations were made against Nasinu Branch by the corrupt secretary Taabesh Akbar (evidence will be attached soon) and then the Council adapted a corrupt practice to investigate and did not allow Nasinu Branch to defend. The branch officials thought it was appropriate to leave the Council meeting since the Council meeting was bias and led by munafiqs. After Nasinu Branch officials had left the meeting the Council decided that Nasinu Branch officials would be suspended. The constitution ruling on this incident was that the moving out of the Nasinu Branch officials was itself a dispute and the matter should have gone to the dispute resolution committee first, then to the working committee and then back to the Council to make a resolution. On every occasion Nasinu Branch officials should have been invited and a proper and full investigation should have been carried out by the officials but instead Hafiz Khan himself decided to pay almost \$12,000.00 from Nasinu Muslim Canteen account and pay a solicitor in Suva to take the officials to Court.

The current interim committee appointed by the corrupt officials of FML is totally unconstitutional and breaks all the rules set for affiliation. Those who were appointed in the interim were always against Nasinu Branch League and the financial status of Nasinu Branch League is a disaster. ([More information](#))

The only way forward to get the branch league out of the grasp of these munafiqs is:

- 1- Either we all Muslims in Fiji put a stand and remove this corrupt regime of FML.
- 2- To break the affiliation from FML and get all our properties back to Nasinu Muslim League which was unlawfully transferred initially.

This is not a difficult task since if majority member of Nasinu Branch sign for this we can break the affiliation and get our properties back and this will also cost almost \$15,000.00 in legal fees. But the benefits of this would be huge such as we would have our land back and with donors ready we can build a brand new girls College. Also we can easily afford to run the primary school totally free of charge. There are many more things we can achieve but our donors are not prepared to spend a single penny while the corrupt regime of FML is still here.

Nasinu Branch League has assets of over 4 million dollars which is the total contribution

Leagues assets.

Court Proceedings on the Removal of Nasinu Branch League

The corrupt trustees decided to take Nasinu Muslim League officials to court at a cost of almost \$35,000.00 which was forcefully funded by Nasinu Branch League. This money could have been used to upgrade our schools. As per the Constitution of Nasinu Muslim League the matter should have gone through clause 85 first before going to court but these munafiq trustees had nothing to loose and they went ahead for a court action. As per the Constitution of Fiji Muslim League these officials should be suspended for a period of no less than seven years. An application was made by the trustees of Fiji Muslim League on 17th September 2007. Copy of the Court application, defence by Nasinu Branch and the corrupt judgement can be found below. Nasinu Branch League disagrees with this Judgement and doubts the integrity of the Judiciary system in Fiji which is evident from the details of the judgement as follows:

1- The application does not relate the entire issue as narrated in the Judgement, so the question remains where did Justice Jiten obtain these information from.

2- As per paragraph one in the judgement, Justice Jiten writes that the officials of Nasinu Branch were removed. Here he never went further to see if the removal was actually carried out, and the answer is NO! He also did not bother to investigate or follow that such a removal should be dealt under clause 84 of the Constitution of FML and the fact remains there was never an investigation done as to why the branch officials walked out of the Council Meeting dated 12-08-2007.

3- Justice Jiten never bothered to investigate or to check the ruling at the Council Meeting where the branch members were suspended, the presence of the officials of Nasinu Branch.

4- Even though the Council has powers to suspend any official or management with or without motions but in any situation the branch officials need to be present on such a Council Meeting.

5- Justice Jiten failed to investigate whether the officials were present or not in the Council meeting where they were allegedly suspended. Justice Jiten also accuses that the Branch members were given enough time to respond to the special committee and that the Branch League seeked a postponement of 14 days. This is a blatant LIE by Justice Jiten Singh as he knew through our defense that the Council ruling was to investigate within 14 days and to investigate 47 counts of allegations' where on the minutes of FML dated 12-08-2007 there chairman of the investigation committee could not honor the council rulings of 14 days because of his personal reasons furthermore the chairman of the committee also admits that he started his investigation after a month. All further details are in our defense. (The fact remains that no actual investigation was ever carried out on the 47 counts of allegations to date and Nasinu Branch League never sought any time extension of 14 days of the Council ruling dated 12-08-2007. The extension time was requested after the chairperson wrote to investigate which was a month after the Councils standing order and details were all given to Justice Jiten Singh in our defense).

6- So as per Justice Jiten's judgement dated 29-02-2008 he can pass a decision on a accused in his court without a hearing (the Council alleged suspension was done without the invitation and presence of Nasinu Branch Officials).

7- Justice Jiten failed to investigate if the Council had followed proper procedures for suspension that was to invite the officials who had walked out of the Council meeting, give them a fair trial, let them present their reasons for walking out of the council meeting dated 12-08-2007 and give them a chance to submit their defense.

8- Justice Jiten Singh failed to investigate that whether the special appointment of the Special Committee Committee was appointed by the Council or if the appointment was made by the speaker himself. He even further failed to investigate who were the actual members of the Special Investigation Committee (members of the investigation committee

were the members of the Fiji Muslims League Management Committee or in other words part of the plaintiffs.

9- Justice Jiten failed to investigate whether or not the Members of Nasinu Branch were given natural justice.

Paragraph 10 of the judgement where Justice Jiten Singh agrees that section 64 of the constitution over-rides section 84 of the FML constitution. But he fails to acknowledge why section 84 was not adopted and he further failed to investigate that whether there was a motion from the floor of the Council to adopt section 64. He even fails to understand that the Council of FML does not have the powers to over-ride any part of the Constitution of FML at anytime.

Paragraph 12 where Justice Jiten's views that the League had powers to remove the branch but he has not indicated on his view that proper procedures are to be followed and documentary evidences are to be provided to make a judgement. He also claims that the defendants were given opportunity to be heard, here you can clearly see that Justice Jiten failed to consider our defense where we have clearly given evidence that we were not given any fair opportunities to do so.

Justice Jiten Singh has mixed two issues on his judgement as follows:

- 1- The Council meeting on 12-08-2007 only discussed the issue of the 47 allegations.
- 2- There was no special Council Meeting for the suspension of the Nasinu Branch Officials.

On the Council meeting 12-08-2007 the branch officials walked out of the Council meeting which has been confirmed by the minutes of FML. So that clearly indicates there was no discussion made regarding the suspension of Nasinu Branch League.

In Paragraph 4 Justice Jiten Singh admits he is basically enforcing the Councils decisions again failing to investigate the Councils integrity and allowing natural justice for the defendant.

From the judgement we have calculated that Justice Jiten's bias judgement has failed to allow natural justice to the defendants, has cost Nasinu Branch League almost \$5 million dollars in damages. Divided Muslim of Nasinu Branch League and restricted Nasinu Branch League members from entering mosques which is under the name of FML. I urge all brothers and sisters to see the truth about the removal of the officials of Nasinu Branch League and would like to applaud the current Government in cleaning up the system where Justice Jiten Singh was finally kicked out from the Judiciary System.

Why Justice Jiten Singh gave a biased and unlawful judgement is only best known by him and FML. If there was a financial gain or not is also best known by him but there is no doubt that he has caused millions of dollars worth of damages to Fiji Muslims League and Muslims of Fiji at large. Nasinu Branch Officials voted not to appeal against the judgement reason being we had lost faith from the Fijian Judiciary System. All the corruption of FML is also with FICAC from the past 4 years then again the integrity of FICAC is also in question as they have done nothing to date. This is clear that Nasinu Branch never got Justice from neither the Police Department and the Courts. Our fight with the corrupt officials with Fiji Muslim League is still there and we have found a way to keep pushing forward. We will get all our schools and mosques back from these munafiqs INSHA-ALLAH one day.

Removal of Maulana Imran Patel

The darkest day in the history of Nasinu Muslim League was when Maulana Imran Patel was forced to leave Koronivia Masjid. Maulana Imran Patels arrival, wages and most living costs were beared by most of the permanent members of Nasinu Branch and only at a later stage did Nasinu Branch pay for his wages. The immigration also acted unlawfully on his issue but the fact remains we invited him to work for us and he signed a contract which was also approved by FML. Maulana left his work in India which took him almost 15 years to get to his position. He complied 100% + his wife was Alima with a teaching experience of six years and provided services to our sisters free of charge. Maulana Imran was told to sign another contract which also included cleaning of all toilets and he would be transferred wherever the FML officials would want but the Nasinu Branch Officials objected

this and advised him not to sign this as it was unislamic and illegal.

Maulana Imran already had a contract and on that contract he was given a work permit where he was not allowed to enter in any other contracts. At the end Nasinu Branch canteen account was used to pay \$15,000.00 in costs which only the FML officials know about. More information about this will be available shortly.

Importation of Vehicle for Tableegh and Dawah

I duty free vehcile was imported by Nasinu Branch League, vehicle number: FF652 which is registered under Nasinnu Branch League and the sole property of the members of Nasinu Muslim League. This vehicle was first approved in the branch management committee and a proper duty free concession was approved by the Government. A letter was sent to Fiji Muslim League for any objection (no objection was noted until such time the vehicle was imported and being used). Lastly a notice of approvals and intention of importation of the said vehicle was on the notice board three months prior to its importation. I suggestion box was provided for suggestions but no objections or suggestions were received. The entire purchase was funded by members of Nasinu Branch League, a member from Suva Muslim League and brothers and sisters from New Zealand. Most of the monies were personally collected by myself and the last elected President of Nasinu Branch League brother Haji Mumtaz Ghani and every donor was individually told that construction of musafiq khana for jamaat and vehicle will be imported for tableegh. Money then was deposited in the general account of Nasinu Branch League and a cheque was written to pay for all the importation costs. A \$30,000.00 vehicle has costed less then half to Nasinu Branch League (\$8,000.00 was only paid by the Branch League) but unfortunatley due to a few munafiq members of Nasinu Branch League and of munafiqs in the management of FML obtained a fatwa from Macauta Muslim League and presented it in the council meetings to confiscate the vehicle and operate the vehicle at the headquarters. These actions were carried out by members who are anti Tableegh and anti Prophet Muhammed (SAW). I as the last ever elected secretary of Nasinu Branch League carried out proper procedures for the importation of this vehicle with full concern and support of the members of Nasinu Branch League.

With the help of the most corrupt ever and unconstitutionally elected speaker of FML, Faizal and Faiyaz Koya rulled against Nasinu Branch League on the issue on this vehicle and since then this vehicle has been mis-used by Hafiz Khan himself and his close agent and cousin Shameem who is also a staff at the headquarters of FML.

Mortgage or Primary School by Hafiz Khan

Hafiz Khan, the man who sells pork and alcohol for a living and the unconstitutionally elected president of FML has mortgaged for thousands of dollars. None of the Nasinu Branch members or officials knew about where the money from this mortgage went to and just because of this the entire umah of Nasinu is involved in this haraam and sinful action. All will be punished for obtaining and being part of ribah (interest) on the day of judgement. There was never a proper working committee or council approval for all of these and the fact remains that Nasinu Branch League cannot obtain funding on interest, this is unconstitutional. The lender Westpac Banking Corporation has mortgaged these properties which is against the constitution and their decision will be challenged.

Pending Motions

On the 27th July, 2006 there were seven motions moved by Nasinu Branch League at the Council of FML as per the constitution of FML. To date no motions have been tabled or addressed, the management of FML on the instructions of Hafiz Khan failed to comply with the constitutions. They were afraid that all the facts would be presented in front of everyone and they would be suspended for life. This is a serious breach of affiliated constitution and there is no doubt these will be used when we file a law suite against FML and withdraw the affiliation to get all our properties back under Nasinu Muslim League. The bank balance of Nasinu Branch was almost \$200,000.00 when we left but in the last 3 years the current and unlawful management have misused all the funds and most of the accounts are running on overdraft. This is what Hafiz Khan and his colleagues wanted, to

obtained every single penny from where ever they could to fund their unlawful and corrupt regime.

Board of Governors

On 21/07/2002, there was a resolution passed at a council meeting to establish a board of Governors for Nasinu Muslim Schools, again the corrupt council of FML carried out these unlawful actions since there is nothing such as board of governors to be established in the affiliated constitution. In order to obtain more folding cash out of the then richest Branch League they devised this unlawful board. I am not sure how much cash the speaker of the day took under the table to rule in their favor but insha-allah I will find out very soon. Until the matter is decided before courts we will have to follow the rulings of the council where it clearly states that six shall be nominated by the branch and four shall be appointed by the National President out of which two shall be independent. The new board shall draw its own rules and regulations and the funds should be managed by the Branch League always.

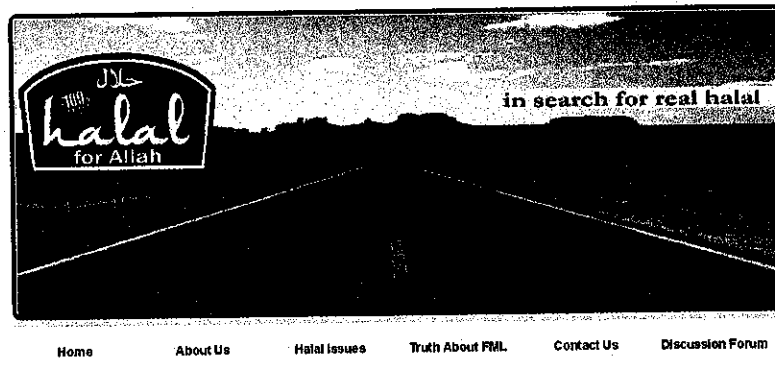
If you look at the current board members appointed by Hafiz Khan you will realize that there is no one from the elected Nasinu branch League. The most important issue is that the funds are being controlled by the pork seller Hafiz Khan himself. If you see the current financial's of Nasinu Muslim schools are on a verge of bankruptcy and we may have to sell some of the properties to pay off the debt, either Koronivia Mosque, Primary school or the College.

\$500,000.00 School Manager Corruption

On 12-08-2007 in a Council meeting of FML the corrupt Hafiz Khan, Tabeesh Akbar and Nisaar Ahmad were trying to get an approval to appoint a paid school manager for Fiji Muslim League Schools. They intended to pay the school manager \$100,000.00/ annum payable by all five colleges in branch leagues. Out of this \$100,000.00 we do not know how much would have been pocketed by these three corrupt officials of FML. But we are grateful to the elected officials of Nasinu Branch who objected strongly and told these three trustees that such unethical and corrupt actions are against the constitution and we opposed the Council against making any such decision. The Council agreed there will not be any such paid school manager for schools. To date Fiji Muslim League has saved \$500,000.00 in cash! We can clearly see the intentions Hafiz Khan has by leading FML and there are countless other issues where Hafiz Khan has and is misusing his position and is making personal gains. From my estimation Fiji Muslim League has lost more than \$9 Millions dollars in cash and kind since Hafiz Khan took the office. This corrupt person with all his friends needs to be kicked out of the office with a Munafiq label.

A. Mishra and Company/ Corrupted Audited Accounts

Please have a look at the documents below, if Mr. Mishra had any truth or honesty on his audited accounts of Nasinu Branch League why to date none of his accounts were presented on Annual General Meetings of Nasinu Branch League. It wont be long before we will be filing matters before courts against such unjustified chartered Accountants in

Updates and Developments with FML

Annual General Meeting FML - 31/3/12 - REALITY!! (some details of this post have been edited out as brothers have promised refo

Annual General Meeting of FML at Nadi Muslim College on the 31st of March, 2013.

To all Fiji Muslim League Members and muslims at large of Fiji:
When we arrived at Nadi Muslim College we were confronted with many security guards hired by the trustees of FML stopping entry of individuals and members who we're on a specific list given to them. There was also a list given to the security barring specific members from entering the meeting. I was one amongst the many in this list and I will photographic evidences below. Those who had FML membership card and their names did not appear on the barred members list were allowed to enter. Apparently there were approx 75 to 100 members whose membership was paid but did not carry their membership cards who were also not allowed in. But some members from Nasinu Branch, Sigatoka branch and other personal friends to the trustees were allowed in even though they did not have the membership card on them.

Constitutional Perspective

The FML constitution does not restrict members who do not have ID cards on entering the AGM as long as their names appear on the membership register. There was no prior announcement or notice that the membership card was necessary or required on the day for entry. FML must have spent approx over \$5000.00 to hire security to prevent my entry. If you look at FML's current financials their headquarter's account barely has a \$5,000.00 balance and if they pay for the security then their account would go into OD. All this effort undertaken by Hafiz Khan and his fellow crooks was just to stop me from entering the AGM. On the other hand Hafiz Khan has been telling other members of FML that he will be replying to all allegations made by me.
The trustees claim that my membership was suspended and pending an inquiry. But from the last 5 years there has been no response on either the inquiry or my membership from the headquarters. This suspension was totally unjustified, against the constitution and unislamic. I have written regarding this to the dispute dissolution committee 6 years ago but there has been no response from them either. The corrupt council of FML with its two munafiq members Faizal and Faiyaz Koya unconstitutionally moved against my suspension 6 years ago.

Financial Account 2012

FML operates 15 Bank accounts but only four full accounts were presented.
Lautoka Muslim Primary School Construction, NO audited accounts were presented for this.
The other 11 accounts which FML operates but does not declare has not been audited as well.
\$905,000.00 was used to pay interest and other creditors incurred by the current crook trustees.
Samabula Shopping Complex interest has gone up to \$500,000.00.

Other Issues

Included in the financial mismanagement of almost 6 million dollars the other questions we intended to ask Hafiz Khan was regarding the actual construction of Samabula Masjid and shopping complex where there was a direct fraud of almost 4 million dollars.

The interest on Samabula Shopping Complex was to be paid by Hafiz Khan himself and Hafiz Khan himself gave a personal Guarantee that he would pay all the interest incurred on this project from his pocket.
Lastly borrowing money on Riba (haram), the trustees of FML have committed a grave sin which involves us all now.

I gave a notice through Fiji Sun and through a mailed notice that I will be available to ask and answer question on all the allegations I have made on Hafiz Khan and his regime. Hafiz Khan is the fraudster and crook who had hired the security to barr me from the AGM using a lame excuse that I have been suspended! Events at Nadi Jame Masjid at Zuhar Salaah on the day of AGM

All the FML members who were locked out from the AGM were waiting for the Police to make a decision in front of Nadi Jame Masjid Carpark while the Muazzin gave the adhan for Zuhar Salaah at Nadi Masjid. We all proceeded for Salaat and were on the steps to enter the masjid. As soon as we entered the Masjid we saw approx six security officers entering the masjid with their shoes on in order to stop us from praying. When we saw this we stood against them and had them removed from the masjid. The security officers advised us that they were there on the instructions of the trustees of FML to lock the masjid. We advised them to immediately leave the Masjid and they did so. Later on a member of Nadi Muslim League confronted us and said if we prayed inside the masjid then he will slaughter us and that the Masjid is reserved for Hafiz Khan and his fellow crooks to pray. While we were dealing with this member and instructed us not to do the Jamaat inside the masjid saying you may pray in the veranda as the Masjid has been reserved for the trustees. We asked the Imam that after the Adhaan the first Jamaat has to be offered inside the masjid then he violently replied that he will not lead the prayer until the trustees are here and he also lied that this was also discussed after Fajr Salaat with the members but brother Shamsheer who is a prominent member who was present in Fajr Salaat confirmed that there was no discussion after Fajr Salaat regarding Zuhar Salaat. I like to make it very clear that I have not said anything against your parents (May Allaah grant them Jannah). If I have done it inadvertently, I seek forgiveness from Allaah.

However, you are conveniently evading the issues and have not cleared the false and unfounded allegations made against me and others by your followers, some of them are as follows:

1. If you are not the so called "AADIL", do you know who he is. If you have not provided him all the confidential informations from FML then who is the culprit from the other two (2) Trustees.
2. Didnt you book Dr. Salem and Dr. Jihani from IDB under false names at Suva Motor Inn, when they came to Fiji as at that time Hafiz was in Brisbane and you were the GS. FML. Didnt you know that if it came to the notice of Immigration or Police they could have been deported and brought disrepute to FML.
3. Didnt you and Haji Tabish Akbar, secretly removed our Hajj Packages from Mosques or ordered them to be removed and I caught both of you red handed removing from Samabula Mosque. The Hajj Packages were approved by the Pesh Imams and Branch Officials in accordance with the ruling of the Council.
4. All of you have been telling our Hujjajs not to go for Hajj with our group and provided false informations that we will not provide all the services and will leave them in Saudi Arabia.

Last year all of you encouraged them to go for Hajj with Mufti Jainul Abadean with Abu Abdullah Group from New Zealand when you were fully aware that Abdullah was not a Registered Hajj Agent and he did not have any Hajj Quota. See what happened if you join fly by nite Agent when about 70 of our people could not go for Hajj and you and Mufti blamed others for your errors.

5. This problem would not have happened if you have accepted the Hajj Quota granted by the Ministry of Hajj for the Muslims of Fiji. I and others including Haji Mohammed Azam Khan of Travel 2000 from New Zealand offered our services free as we have the necessary experience in arranging the Hajj services but you did not accept.

6. The issue here is as to how best we can help those who have been

We have noted that you just provided some rations and are keeping rest of the money.

7. You still make false allegation that I have not returned the Hajj money for late Musa Suleman (May Allah grant him Jannah) from Raki Raki when you are fully aware we joined the TRAVELKING GROUP, Akbar Jariwalla from Melbourne and all the money was sent to him as you did for those who went with Nadimah Group. I returned over \$4500.00 to his wife and Akbar confirmed that he returned AU\$3000.00 to his adopted son Sadru Musa in Australia. In fact I told Akbar that he should have sent all the money to Fiji and not paid to Sadru. As previously advised you can check with Maulana Patel, Current Pesh Iman, Nadi Mosque and Haji Mohammed Firoz Khan from Raki Raki.

8. In 2008 one of you used your wife to find out from the Doctor with whom I arranged to provide Menengitis injections to our group and told the Saudi Embassy that those going for Hajj did not have SWINE FLU INJECTIONS when it was not required for Fiji. You can go so low being the Trustee?

9. Your record may go in the Guinness Book of record in suspension of the Branches. NASINU (about 8 years), VALELEVU, SUVA, RARAWAI, CUVU, ETC.

It has been the policy of FML to try to solve the problems in a Branch with 6 months and call the Special General Meeting to elect the new Office Bearers.

Regarding Nasinu Branch, both of you are at fault in taking the matter to Court and highering QADIANI and HINDU lawyers to fight the case.

You are fully aware as to what happened to Brother Gul Zaman, who took SAMA Officials from New Zealand to court and break away group from the Green Valley Mosque, NSW, Australia. We are sending this email after much thought and reserarch. It has been noted that there is urgent need for corrugated irons so that our people can built their damaged houses.

Just after the disaster I spoke to Haji Azmat Khan, Speaker, FML and he advised that the Acting President, Brother Abdul Qaiyum Khan visited the affected areas with his team. So I contacted and thanked him for the effort.

He briefed me regarding the damages and people urgently require to built their houses.

I suggested that on our request IDB provided US\$100,000.00 for the flood disaster which happened early this year. It is noted from the attached minutes of the Council Meeting that FML did not provide any assistance from that money with the excuse that enough funds had been provided by our Muslim Brothers and Sisters from Overseas and FML wants to divert that money to relocate the FATIMAH GIRLS HOSTEL (FGH) from Ba to Suva. I suggested to Brothers Qaiyum Khan and Haji Azmat Khan that US\$100,000.00 has been provided by IDB for the NATURAL DISASTERS and that money must be urgently provided to the affected Muslims of Fiji.

Haji Azmat Khan advised that as Speaker he cannot direct FML where to use that money but if any Branches submit the proposal, he can look into it.

Brother Qaiyum Khan promised to submit the proposal to the Executive. It is further suggested that US\$150,000.00 which has been allocated by IDB to the Makoi Vocational Centre (MVC), should also be used for this cyclone disaster.

The Current Officials of FML could not operate the ISLAMIC INSTITUTE OF THE SOUTH PACIFIC (IISP) which has been previously operating very successfully, the Ladies will not be able to operate the MVC.

We have to be practical as due to this Coup Culture in Fiji most of our people are trying to migrate overseas and the educated children are looking for greener pastures. The MVC will be another white elephant as the IISP.

So you have to think seriously and what is the best to utilise the US\$250,000.00 which has been provided by the IDB for the Muslims of FIJI. FML should get from those affected as to what type and length of corrugated irons they need and arrange one of the tin factories to supply them so that those affected can build their houses.


FML must also look at the other sister Organisations like MACUATA MUSLIM LEAQUE (MML), MANATUL ISLAM, ALE HADITH, ANSARUL ISLAM, ETC. We should also not forget our Brothers and Sisters affected in Samoa and provide some grant from that money to SAMOA MUSLIM ASSOCIATION whose President is Brother Mohammed Umar from Fiji.

He advised that their temporary Mosque which they have been operating from the house of Brother Stanley has been damaged with the root crops, etc.

We are sending this proposal to also Haji Azmat Khan, Speaker, Haji Mohammed Ramzan, Patron, FML, Sheikh Al Shangiti, Manager, IDB who provided the grants and others and hope you will seriously help the affected Muslim of Fiji.

I further request if any of you can send me the photos of the

Again as per relevant Islamic scholarly argument:

Whoever slanders his brother or accuses him of an evil deed has to repent to Allaah, ask his brother's forgiveness, and avoid everything that causes harm to a fellow Muslim. Abu Hurayrah (may Allaah be pleased with him) reported that the Prophet (peace and blessings of Allaah be upon him) said: "Whoever believes in Allaah and the Last Day, let him say something good or else remain silent." (Reported by al-Bukhaari, 11/256, and by Muslim, no. 47).

Abu Dharr (may Allaah be pleased with him) said: "I heard the Messenger of Allaah (peace and blessings of Allaah be upon him) say: 'No man accuses another of an immoral deed or kufr, but it will come back on him, if the person he accuses is not as he says he is.'" (Reported by al-Bukhari, 10/388)

It is not permissible for any Muslim to spy on his Muslim brother or to seek out his faults. If he accidentally sees him in a doubtful place or seeming to behave in a doubtful manner, he should not accuse him unless he sees him with his own eyes doing a wrongful action. He should advise and counsel him, then if he insists on doing that thing, and there is fear that he may harm other Muslims, or if one is asked about him for a legitimate reason, then he should tell those who have something to do with it about what he knows. But he should not broadcast it unless the person does the evil action openly, because this will only help the Shaytaan against him and stop him from repenting. Allah knows best!


We have enough issues from the outside world displaying ignorance against Muslims. At least have the decency to go through the right, pious and decreed Islamic channels if you have issues with the FML. Instead of acting like a gossiping old woman in the village because she has nothing better to do than cause dissent amongst the good villagers,. You are making a mockery of yourself and of us all.

The Board of Governors is usually made up of muslims of the Ba and few from outside depending on their expertise. Dr Dean is the Chairman. Alhamdulillah, we should all be proud of that . He is after all from Ba and also a student of the College.

Whether he has paid the loan to IDB or not is none of my concern and I do not think it should be your concern either. If he is doing anything wrong it is between him and Allaah azzawjal.

Br Yunus, I have been receiving your emails and from other brother about FML and particularly Br Hafiz but I have deliberately kept not replied to anyone.

I do wish to tell you though that sending emails to all and sundry whether they have any interest in the matter or not is not a good thing. You should refrain from that and address it to people concerned. It is against Islam to do so especially when the emails say bad things about another brother.

Br Hafiz did mention about wanting to shift the Hostel to Suva and not closing it. He has good reasons for doing it. Some will agree with his reasons and some will not agree. The present officials of FML are the best people to make any decision about how affairs of muslims in Fiji should be run.

You and I now live in Australia and NZ and I think we should keep out and stop interfering in how things are done there unless ofcourse it is against Islam.

It is sad to see these exchange of emails being sent to even non muslims. Even this email of yours is being sent to brothers who now live overseas and some have lived overseas for more than 10 years. Why should they interfere in affairs of FML now.

You and your other brother from Wiri had been sending emails basically questioning FML AFFIC and FIANZ on halal issues in the past. Now this, the website criticising FML, haj issue etc. One gets the feelings only few of you know everything and the rest are useless.

My advice is please stop all this. I am sure officials of FML are not that stupid to make decisions which have no good reasons. Whether the hostel is in Ba or timbaktu, it does not matter as far as the benefit is derived by muslims.

Please refer to the Council Meeting minutes of FML in particular regarding the closure of FATIMAH GIRLS HOSTEL, BA.

As you being the President of FML Ba Branch at that time were instrumental in getting the substantial grants from SHEIKH SALEH KAMIL for the following projects in Ba

1. FATIMAH GIRLS HOSTEL (FGH): Sheikh Saleh built the hostel in memory of his mother. It is for the use of poor and needy Muslim girls from Sigatoka to Raki Raki and girls from the Island Countries.
2. KAMIL COLLEGE AUDITORIUM
3. KAMIL COMMERCIAL BUILDING: It is near the Ba Jame Masjid and the rents received from it is suppose to pay the expenses of FGH.

As you are aware that currently I am the Representative for Iqraa for Human Relations, the Charitable arm of the DALLAH AL BARAKH. It is noted with concern, that FML wants to close the FGH hostel in Ba and shift to Suva. There are 2 buildings lying idle after the closure of ISLAMIC INSTIUTE OF THE SOUTH PACIFIC and FML wants to convert the buildings into the girls hostel. FML renovated the building and shifted its Office from Samabula to Nabua. The buildings are at very isolated place and back of them are squatters. There were number of breakins and the Office Staff have also been attack.

FML again shifted back the HQ to Samabula. I dont think any parents will like to send their daughters to stay there as it is

also been attack.

FML again shifted back the HQ to Samabula. I don't think any parents will like to send their daughters to stay there as it is not a safe place for a girls hostel. There is danger of getting them raped.

The Muslims of Ba are very much concerned that the 3 projects funded by Sheikh Saleh Kamil suppose to be managed by BA BRANCH but they blame you being the BA BRANCH PRESIDENT at that time in agreeing to form a Board Of Governors to manage the Kamil College and the girls hostel.

You may be also aware that the Ba Muslim Primary School, Rarawai Muslim Primary School and Talaiya Muslim Primary school are all under the Kamil Board of Governors and Ba Branch has no say in their running.

Ba Branch only has the Ba Jame Masjid under its control and the Masjid was flooded twice.

One of the Language Teacher from Kamil Muslim College went to collect donations from Canada and USA for the girls hostel and he advised Brother Haji Adam Buksh former Ba Branch Secretary that Sheikh Saleh Kamil agreed for the transfer of the girls hostel to Suva and provided grant of \$50,000.00. What a lie. Nothing is mentioned in the minutes but FML wants to request funds from IDB for renovation. Sheikh Saleh is not aware of this transfer and I request you to please URGENTLY advise the National President, Hafiz Khan the history for the funding of the FGH by Sheikh Saleh and to stop the transfer to Suva.

No parents will like to send their daughters from Sigatoka to Raki Raki to Suva. They will be deprived of getting the best education if they cannot attend the Kamil College.

If FML cannot manage the FGH they must give it back to Ba Branch and provide all the rents from the Commercial building or 50% to Ba Branch. They will be able to run it better than the current Board. I am surprised to note that Dr. Riaz Dean is responsible for the management of the hostel. He became doctor under the IDB Scholarship Scheme but have not refunded the money spent on his education.

So please urgently advise Hafiz that he MUST stop the transfer of the FGH to Suva and should return it to the Ba Branch together with the rents received from the Commercial building.

I am currently in Saudi Arabia came for Hajj as the guest of Saudi Ambassador and will meet the Iqraa Officials and Sheikh Saleh next week.

If you do not succeed in stopping the transfer of the girls hostel from Ba to Suva, I will have no alternative but to inform Sheikh Saleh. I have also Officially informed the FML Secretary to stop this transfer but as usual have not received any response from him. I have also discussed this matter with Sheikh Mustafa Madani who was the Project Manager for Sheikh Saleh Kamil for this 3 projects and he wants to meet me next week.

By copy of this email I am also requesting Haji Azmat Khan, Speaker FML to also inform the Council the history of the girls hostel and not to transfer to Suva as he is also fully aware of the funding of the 3 projects and your involvement for them.

Please urgently do the needful and advised me accordingly. Waiting for your urgent response.

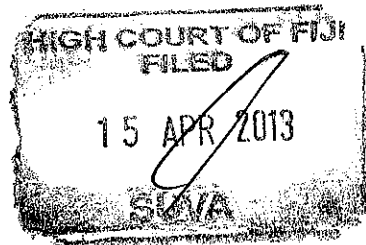
