**AFFIDAVIT IN SUPPORT**  
[of application for interim injunction]

I, **Mohammed Taabish Akbar** of Suva, Fiji, Businessman and Trustee make oath and say as follows:

1. I am the General Secretary of the Fiji Muslim League and one of its Trustees. I am duly authorised by the other trustees to make this affidavit on their behalf.
2. This affidavit is being made in connection with an application for urgent injunctive relief against the Defendants in this action.
3. I depose to the facts herein as within my knowledge and that as acquired by me in the course of my duties except where stated to be on information and belief and except where I verily believe to be true.

**Background**

4. The League is a body duly registered under the Registration of Religious Bodies Act and has branches operating in all districts of Fiji.

5. The affairs of the League, its branches and subsidiary organizations are conducted in accordance with the Constitution and Rules of Fiji Muslim League, adopted on 9 January 2005.
6. The League is empowered to establish, encourage, maintain and support Branches and subsidiary organizations to cater for the interests of Muslims which are as follows:

9. The League gives scholarships to needy students to assist them in their education and for this purpose, the League has set up a 'Fiji Muslim League Education Trust Fund Scholarship.'
10. The League provides counseling services for school students and married persons so as to assist in upholding the institution of marriage and helping school students in their personal problems.
11. The League provides assistance to those in need of medical and health assistance. Funds are provided to those who travel overseas for medical emergencies or where needy persons cannot afford local (expensive) surgeries.

12. Finally, the League provides assistance to the Fiji DISMAC office in times of natural disasters and has been very active over the several Floods/Cyclones that have hit Fiji in the recent past in providing food and other emergency assistance to those affected.

#### **Feroz Gulam Mohammed**

13. Feroz Gulam Mohammed is a former member of the Fiji Muslim League whose membership had been suspended from 22 August 2007.

Annexed hereto and marked "A" is a copy of the said suspension letter.

14. The said membership was terminated on 31<sup>st</sup> March 2013.

Annexed hereto and marked "B" is a copy of the said termination letter.

15. There has been a prior civil case between the League and Feroz where certain injunctive orders had been made against him by Justice Jiten Singh in Civil Action No. 436 of 2007.

Annexed hereto and marked "C" is a copy of the Orders in the said action.

16. The said action was discontinued in May 2011 as the vehicles and documents the subject of the said action had been recovered.

#### **Interference in the work of the Plaintiffs**

17. The League had its Annual General Meeting on 31 May 2013 here Feroz and his cronies tried to enter the meeting to cause disruption.

18. The services of the officers from Nadi Police Station was sought and order had been restored to the meeting venue.

19. Quite apart from this, the Feroz is in the habit of writing long emails making derogatory comments against the Plaintiffs and he continues to circulate these emails to any person's email address he can get.

20. I am concerned that such conduct, whilst based on falsities, has been damaging to the Plaintiffs.

#### **Defamatory and False Publications**

21. Feroz has recently published a number of derogatory and false statements against the Plaintiffs.

22. I have recently come to know that Feroz maintains a website having the web address as follows:

23. I verily believe that a separate affidavit will be filed on the contents of the website and I adopt the said affidavit as if the contents were set out herein.
24. Not only are most of the contents of the said website defamatory and false, there is also reference to the judiciary of Fiji and a lot of scathing remarks have been made by Feroz against the judiciary.
25. Feroz caused an advertisement to be published in the second Defendant's **Fiji Sun** issue of 28 March 2013 which contained or imputed false and defamatory information about the Plaintiffs.  
Annexed hereto and marked "D" is a copy of the said advertisement.
26. The Plaintiffs deny all allegations made or imputed by the said advertisement and the material contained in the said website and say that those allegations are baseless and without any merit whatsoever.

**Actual and likely pecuniary damage to reputation**

27. The League since its inception in **31<sup>st</sup> October 1926** has worked hard to build its reputation within the Islamic communities in Fiji.
28. The League has made its contribution in all aspects of Fiji's public life, whether be it in education, religion, social services or services in the times of hardship such as in times of natural disasters and continues to assist needy people regardless of race, religion or creed.
29. The Defendants false and defamatory publications are or is likely to cause damage to the reputation that the League has built up in its name.
30. The League is funded by donations from members and the international community. With the level of false and defamatory publications being made against it by Feroz, the League can be affected in terms of its donations it receives. If donations are decreased, the League will not be able to provide its charitable services in the manner it previously did.
31. Feroz has threatened that he will continue to spread further material against the Plaintiffs through the second Defendant.

Annexed hereto and marked "E" is a copy of an email from Feroz dated 9 April 2013.

32. I very believe that unless restrained by an Order of this Court, the first Defendant's conduct will cause irreparable harm to the Plaintiffs and damages may not be an adequate remedy.
33. The League will also be affected in terms of how the ordinary members of the public view it, especially by those members who have contributed to building the organization that the League today is and from whose continued daily donations the League functions.
34. I humbly seek an Order in terms of the Summons filed herein.


The reasons for your expulsion are as follows:-

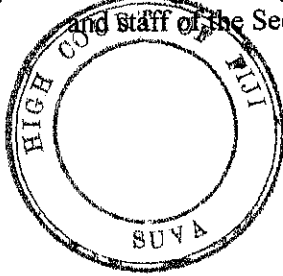

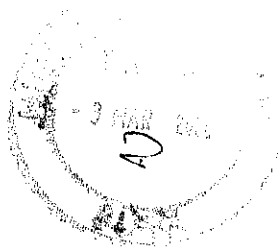

### **Annual General Meeting of FML at Nadi Muslim College on the 31<sup>st</sup> of March, 2013.**

To all Fiji Muslim League Members and muslims at large of Fiji:  
When we arrived at Nadi Muslim College we were confronted with many security guards hired by the trustees of FML stopping entry of individuals and members who we're on a specific list given to them. There was also a list given to the security barring specific members from entering the meeting. I was one amongst the many in this list and I will photographic evidences below. Those who had FML membership card and their names did not appear on the barred members list were allowed to enter. Apparently there were approx 75 to 100 members whose membership was paid but did not carry their membership cards who were also not allowed in. But some members from Nasinu Branch, Sigatoka branch and other personal friends to the trustees were allowed in even though they did not have the membership card on them.

### **Constitutional Perspective**

The FML constitution does not restrict members who do not have ID cards on entering the AGM as long as their names appear on the membership register. There was no prior announcement or notice that the membership card was necessary or required on the day for entry. FML must have spent approx over \$5000.00 to hire security to prevent my entry. If you look at FML's current financials their headquarter's account barely has a \$5,000.00 balance. All this effort undertaken by Hafiz Khan and his fellow crooks was just to stop me from entering the AGM. On the other hand Hafiz Khan has been telling other members of FML that he will be replying to all allegations made by me. The trustees claim that my membership was suspended and pending an inquiry. But from the last 5 years there has been no response on either the inquiry or my membership from the headquarters. This suspension was totally unjustified, against the constitution and unislamic. I have written regarding this to the dispute dissolution committee 6 years ago but there has been no response from them either. The corrupt council of FML with its two munafiq members Faizal and Faiyaz Koya unconstitutionally moved against my suspension 6 years ago.

### **Financial Account 2012**

- 1- FML operates 15 Bank accounts but only four full accounts were presented
- 2- Lautoka Muslim Primary School Construction, NO audited accounts were presented for this.
- 3- The other 11 accounts which FML operates but does not declare has not been audited as well.
- 4- \$905,000.00 was used to pay interest and other creditors incurred by the current crook trustees.
- 5- Samabula Shopping Complex interest has gone up to \$500,000.00.

### **Other Issues**

- 1- Included in the financial mismanagement of almost 6 million dollars the other questions we intended to ask Hafiz Khan was regarding the actual construction of Samabula Masjid and shopping complex where there was a direct fraud of almost 4 million dollars.
- 2- The interest on Samabula Shopping Complex was to be paid by Hafiz Khan himself and Hafiz Khan himself gave a personal Guarantee that he would pay all the interest incurred on this project from his pocket.
- 3- Lastly borrowing money on Riba (haram), the trustees of FML have committed a grave sin which involves us all now.

I gave a notice through Fiji Sun and through a mailed notice that I will be available to ask and answer question on all the allegations I have made on Hafiz Khan and his regime. Hafiz Khan is the fraudster and crook who had hired the security to barr me from the AGM using a lame excuse that I have been suspended! He has proved with his cowardly actions that he has no other avenues of saving his backside. He has proved to the world with his weak actions by locking other very concerned brothers including me outside the AGM that he is a liar, thief and accepts all the allegations made on him. Hafiz Khan made a statement confirming that the \$905,000.00 he used to pay interest and other debts of FML did come from the funds collected and received for flood appeal and education trust fund. His justification for this vile act was that FML has the authority to use any funds in any of its account no matter it be or received for flood appeal, zakaat or the education fund to meet its dues and activities in any other cause. This shows the weak mental ability, accounting ability, Islamic sense and financial ability of Hafiz Khan and his regime. What kind of a low life, self-centred and hypocrite man



can use the money allocated for the poor and needy! This means he has lied and broken the trust of every individual who has sent money towards the flood relief!

### **Mufit and Scholars at AGM**

I was reported that Mufti Saizad Ali, Hafiz Musa Patel and Hafiz Ibrahim Patel were present in the AGM even though they were aware that close to a 100 members were locked out from the AGM depriving them of their rights which is against shariah and the teachings of Prophet Muhammed SAW. They kept their silence and chose not to speak out against the cruel actions of Hafiz Khan and endorsed the actions as shariah complied. These respected scholars also endorsed that the funds obtained on Riba is Halal. I have decided to stand against these scholars who have created a division amongst Muslims and whose actions are promoting munafiqat by advertising their Photographs together with their names and action on my web page to warn brothers not to support the institutes they are working for. I will write to Darul-uloom deoband and A;-Azhar seeking advice as to what actions to take against such scholars who behave like this with the ummah. I am writing this with full fear of Allah SWT and I know if I write and promote wrong then Allah SWT will surely punish me. Even though the 100 members requested Mufti Saizad to voice the truth and promote the teachings of Prophet SAW in the AGM but he failed to do so and did otherwise.

### **Events at Nadi Jame Masjid at Zuhar Salaah on the day of AGM**

All the FML members who were locked out from the AGM were waiting for the Police to make a decision in front of Nadi Jame Masjid Carpark while the Muazzin gave the adhan for Zuhar Salaah at Nadi Masjid. We all proceeded for Salaat and were on the steps to enter the masjid. As soon as we entered the Masjid we saw approx six security officers entering the masjid with their shoes on in order to stop us from praying. When we saw this we stood against them and had them removed from the masjid. The security officers advised us that they were there on the instructions of the trustees of FML to lock the masjid. We advised them to immediately leave the Masjid and they did so. Later on a member of Nadi Muslim League confronted us and said if we prayed inside the masjid then he will slaughter us and that the Masjid is reserved for Hafiz Khan and his fellow crooks to pray. While we were dealing with this member and instructed us not to do the Jamaat inside the masjid saying you may pray in the veranda as the Masjid has been reserved for the trustees. We asked the Imam that after the Adhaan the first Jamaat has to be offered inside the masjid then he violently replied that he will not lead the prayer until the trustees are here and he also lied that this was also discussed after Fajr Salaat with the members but brother Shamsheer who is a prominent member who was present in Fajr Salaat confirmed that there was no discussion after Fajr Salaat regarding Zuhar Salaat. Allah SWT is our witness that during the time of the Adhan and Jamaat time we had no knowledge that they Jamaat will be delayed for the people in the meeting as we were a visitor there. The only words I said to the Imam was that you are in a masjid and you should fear Allah SWT and not Hafiz Khan and I also warned him that if he was trying to compromise with shariah then we will expose his actions to the world. If Maulana Ibrahim Patel had any fear of Allah SWT and had knowledge of the rules of Imamah, then after the adhan he would have been there to inform everyone that the jamaat will be delayed and not to send kafirs to close the Masjid. Because of this there was three sets of Jamaat of Zuhar that day, the imam should be ashamed of this and so should the trustees of FML.

### **Faiyaz Koya**

This man who I respect for being a Muslim or maybe a momeen in the eyes of Allah SWT, Allah SWT knows best. Lautoka Branch member has confirmed this that Faiyaz and Faizal Koya have never been paid members of Lautoka Branch League till days before their appointment. Their minutes book confirm that they have never been a member of Lautoka Muslim League from the last 7 years at least prior to their appointment. They never existed as members of Lautoka Branch League in history, how they became members and how Hafiz Khan claims they have been members for years can be best answered by these two brothers themselves under oath of the Holy Quran. Faiyaz Koya has repeatedly misguided FML officials and lied on various aspects and the biggest lie of his was when he stated he carried out inquiry on the allegation on Nasinu Branch League. The report he presented against Nasinu Branch was totally unjustified, biased, filled with fraud and unislamic and he shall die knowing this fact.

At the Council Meeting Maulana Ibrahim Patel blatantly lied that I instructed for the azaan, that I hassled and abused him and threaten to beat him. I have countless members to support me who were present on the occasion that Maulana Ibrahim Patel is lying and that I did no such thing. After his complaint Faiyaz Koya moved to permanently revoke my membership and it was seconded in the council. Here you can see how FML operates in a criminal manner revoking membership of members who are against Hafiz Khan and his corruption. I condemn such a ruling and I challenge Hafiz Khan to take me to court and try to revoke my membership.

### **Nadi Police Officers.**

We invited the Police to come and intervene and as usual they arrived and sided with the trustees as usual. One of the Police officers invited me to come inside and talk directly to Hafiz Khan which I accepted, half way towards the meeting the Officer handed me over to the security officers who man handled me and kicked me out right in front of the officer

who I complained to several times but he stood there laughing at me. Nadi Police station is a waste of tax payers money as they have no integrity. This is the same with the whole Police Department of Fiji as I have countless experiences with them before where I have complained with them countless times but no actions have been taken to date.

#### **Security Officers**

The spokesperson for the security Guards told us upon asking by brother Shamsheer that they have been and hired and are under instruction from Fiji Military force. When I asked the security officer once again he realised he was not supposed to give us this information and he refused to tell us more. After this we decided not to further debate with the security officers as they had Military backing. We Fiji Muslims totally condemn and reject what the Security officer claim but to get this cleared we will write to the Chief in Command to investigate these allegations and clear the air that Fiji Military force was not party to any actions that took place that day. I will make an effort to see the commander in charge tomorrow morning.

We would like to tell all the concerned Muslim brothers and sisters of Fiji that we will still continue our fight to setup an inquiry board on FML officials over the 6 million dollar corruption and involvement in interest. Please continue to visit our web page for further updates.

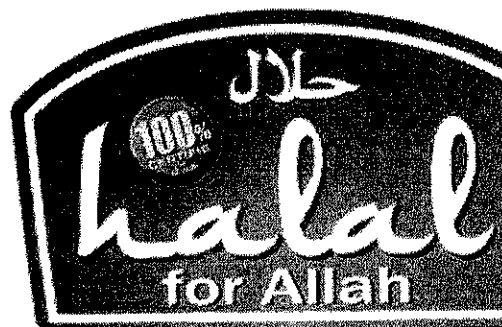

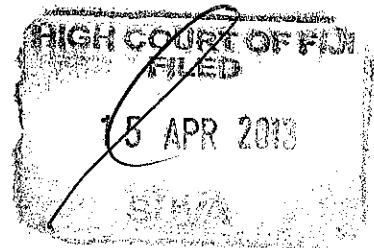
